What are the tariffs imposed by Sweden in 2022?

Tariffs imposed by Sweden in 2022 are below. The maximum rate of tariff in percentage on any product is 319.62. The simple average tariff across all products is 1.96. The trade weighted average tariff is 1.39. The total duty free imports in thousands of US dollars are 44,841,809.36 and duty free tariff line items share is 68.51.

Which country imports the most PV modules to Europe?
