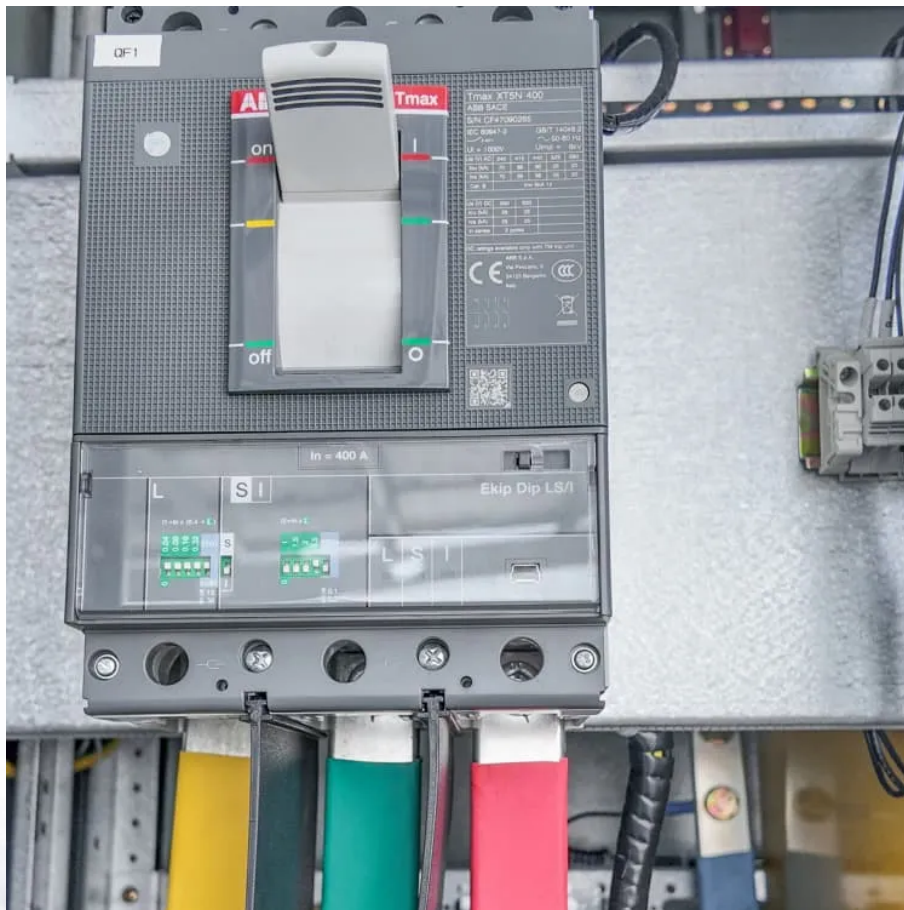

What is the NT battery subsidy?

National battery subsidy - a federal battery rebate is available, reducing the cost of installing a battery by around 30%. There was an NT battery subsidy but it ended early June 2025. There was a Home and Business battery scheme that offered grants for batteries, but it ended June 4, 2025.

What is the WA residential battery scheme?

The WA Residential Battery Scheme, launching by 1 July 2025, will provide 20,000 households with rebates and interest-free loans to install home battery systems. The program aims to make energy storage more affordable, helping Western Australians cut electricity bills and improve energy resilience.
