fordability and Price Expectations Affordability remains a central objective of the Davis Administration's energy reform programme. Historically, The Bahamas has had some of the highest electricity costs in the region, with consumers paying between \$0.28 and \$0.35 per kilowatt-hour, largely due to dependence on imported fuel.

How will a new energy system affect the Bahamas?

Comprehensive upgrades to our country's transmission and distribution infrastructure, and switching from heavy and diesel fuels to solar power and natural gas, will create new efficiencies and reduce the price of electricity in The Bahamas. But it won't happen overnight - it will take time to upgrade our grid and to integrate cleaner energy.
